HBA FILES WRIT OF MANDAMUS REGARDING CITY OF LEMOORE IMPACT FEES

The HBA filed a Petition for Administrative Writ of Mandate on April 4th in response to the recently adopted Lemoore impact fees. The fees, in our belief exceed the legal parameters as defined by the Fee Mitigation Act (AB1600), the Quimby Act (parks), and the California Constitution.
